





Horizon Europe: initial figures (2021 calls)



 Over 1500 funded projects involving around 3000 distinct organisations, including over 1600 from nonacademic sectors

Italian participation in MSCA 2021 calls:

- 140 distinct organisations receiving funding (under all calls)
- 210 researchers funded under MSCA
 Postdoctoral Fellowships
- Success rate of Italian researchers in MSCA PF: 18,4% (vs PF average 14,3%)

Organisation

- Any legal entity
- From academic or non-academic sector
- Beneficiary or associated partner
- Applies to Doctoral Networks, Staff Exchanges and COFUND



Individual researcher

- Any nationality
- Specific conditions (mobility rule, PhD, nationality/residence for Global PF)
- Applies to Postdoctoral Fellowships jointly with host in EU/AC

MSCA Postdoctoral Fellowships: Who can apply?



Postdoctoral researcher

- Have obtained a PhD at the date of the call deadline
- No age restriction
- Maximum 8 years (full-time) research experience since award of the (first) doctoral degree



Any Nationality

 Except for Global Fellowships: the researcher must be a national or long-term resident (5 years) of an EU Member States or Horizon Europe Associated Country

Mobility rule



 Must not have resided or carried out their main activity in the country of the beneficiary (for European Fellowships) or associated partner (for Global Fellowships) for more than 12 months in the 36 months immediately before the call deadline



Restrict resubmissions with score less than 70% to the following year

MSCA Doctoral Networks

- Multi-beneficiary action to set up innovative doctoral programmes, including:
 - Industrial Doctorates
 - $\circ~$ Training in academia and industry
 - Joint supervision

• Joint Doctorates

- o Joint collaborations leading to a joint/double/multiple doctoral degree
- Joint selection, supervision and governance structure
- Pre-agreement for joint degrees required

• Recruited researchers:

- **doctoral candidates,** i.e. researchers without a doctoral degree at the date of the recruitment; mandatory enrolment in a doctoral programme in at least 1 EU MS/AC (at least 2 for Joint Doctorates)
- researchers apply to vacancies published by the institutions participating in the projects
- Focus on career development plan, supervision, training: research and transferable skills
- Who applies?
 - **consortia** of universities, research institutions and research infrastructures, businesses including SMEs, and other socio-economic actors; each beneficiary to recruit at least 1 researcher
 - at least **three independent legal entities**, each established in a different MS or AC; minimum of 1 beneficiary from a MS (on top of this minimum, any entity from any third country can join)
 - Resubmission restrictions for applications receiving a score below 80% in the previous call

DURATION Max 4 years (max 5 years for Joint Doctorates only) COMPOSITION Min 3 organisations in 3 ≠ EU MS or HE AC (at least 1 MS)



FELLOWSHIP Between 3 and 36 months (up to 48 months for Joint Doctorates only)






MSCA and Citizens 2023



- Aim: To bring researchers and researchers closer to children, families and the public at large
- Who applies? One or more legal entities established in an EU Member State or HE Associated country
- EU contribution
 - Lump Sum contributions
 - Contribution estimated between **100-300k€ per annual edition** of the European Researchers' Night
- Duration
 - The call 2023 covers two successive editions (2024-2025)
 - Applicants are encouraged to submit proposals covering activities for both 2024 and 2025, including the
 organisation of two successive editions (2024 and 2025) of the European Researchers' Night and
 implementation of Researchers at Schools activities during the project duration.
- Call
 - 2023: 20 Jun 2023 25 Oct 2023; 15.42 M€
 - No call in 2024





MSCA Seal of Excellence

- Under MSCA Postdoctoral Fellowships and COFUND
- The <u>Seal of Excellence</u> is awarded to applications achieving a score of 85% or above not retained for funding under MSCA PF and COFUND
- Quality label, helping recipients to attract other potential funders
- Specific support schemes exist for MSCA Seal of Excellence holders (including several in Italy). You will find the complete list <u>here</u>


